For continuous contact we recommend gloves with a breakthrough time of at least 240 minutes, with the preference for a breakthrough time greater than 480 minutes. For short term or splash protection we recommend the same. We are aware that suitable gloves offering this protection are not available. In this case, a shorter breakthrough time is permissible, provided the procedures for maintenance and timely replacement are followed. The thickness of the gloves is not a good measure of the resistance the gloves give against a chemical substance, as this depends on the exact composition of the material of the gloves.
